## SerComm Announces September Sales

Taipei, Taiwan, 8<sup>th</sup> October 2012 - SerComm Corporation (TSE: 5388), a leading manufacturer of broadband and wireless networking equipments today announced consolidated net sales for September of NT\$1.77 billion (US\$60.5 million approximately), which represents a 73% year-over-year increase compared to NT\$1.02 billion (US\$34.9 million approximately) for the revenue of September 2011. Net sales for the 3rd quarter of 2012 was NT\$5.53 billion (US\$188.8 million approximately), which represents a 61% increase compared to NT\$3.43 billion (US\$117 million approximately) for the revenue of 3Q'11.

Cumulatively, consolidated net sales from January to September of 2012 was NT\$14.99 billion (US\$511.7 million approximately), which represents a 60% year-over-year increase compared to the revenue of NT\$9.35 billion (US\$319.1 million approximately) for the same period last year.
