## **Sercomm Announces September Sales**

Taipei, Taiwan, 6<sup>th</sup> October 2014 - Sercomm Corporation (TWSE: 5388), a leading manufacturer of broadband and wireless networking equipments today announced net sales for September 2014 of NT\$2.09 billion (US\$69.08 million approximately), which represents a 31.9% year-over-year increase compared to NT\$1.58 billion (US\$52.38 million approximately) for the revenue of September 2013.

Net sales for the 3<sup>rd</sup> quarter of 2014 was NT\$6.15 billion (US\$203.75 million approxmately), which represents a 21.3% year-over-year increase compared to NT\$5.07 billion (US\$ 167.99 million approxmately) for the revenue of 3Q 2013. Cumulatively, consolidated net sales from January to September of 2014 was NT\$16.85 billion (US\$557.78 million approximately), which represents a 18% year-over-year increase compared to the revenue of NT\$14.27 billion (US\$472.66 million approximately) for the same period last year.
