## **Sercomm Announces June Sales**

Taipei, Taiwan, 7th July 2014 - Sercomm Corporation (TWSE: 5388), a leading manufacturer of broadband and wireless networking equipments today announced net sales for June 2014 of NT\$2.09 billion (US\$69.90 million approximately), which represents a 24.5% year-over-year increase compared to NT\$1.68 billion (US\$56.13 million approximately) for the revenue of June 2013.

Net sales for the 2<sup>nd</sup> quarter of 2014 was NT\$6.02 billion (US\$201.42 million approxmately), which represents a 28.9% quarter-over-quarter increase compared to NT\$4.67 billion (US\$ 156.21 million approxmately) for the revenue of 1Q'14 and 18.3% year-over-year increase compared to NT\$5.09 billion (US\$ 170.34 million approxmately) for the same period last year. Cumulatively, net sales from January to June of 2014 was NT\$10.69 billion (US\$357.63 million approximately), which represents a 16.2% year-over-year increase compared to the revenue of NT\$9.20 billion (US\$307.73 million approximately) for the same period last year.
